FOR ALL COURSES TAUGHT OUTDOORS, YOU WILL BE REQUIRED TO BRING FULL PROTECTIVE EQUIPMENT TO CLASS EACH DAY. THIS INCLUDES; *BOOTS, PANTS, JACKET* OR *COAT, GLOVES, HELMET*, AND *NOMEX HOOD*. YOUR INSTRUCTOR WILL DECIDE WHEN & WHAT WILL BE WORN AT THE APPROPREIATE TIME.

LONG PANTS AND SHIRTS WITH SLEEVES SHALL BE WORN TO ALL CLASSES. SHORTS, BODY SHIRTS, LONG SIDEBURNS, OR BEARDS WILL NOT BE PERMITTED. JEWELRY PROTRUDING THROUGH FACE OR HEAD IS TO BE REMOVED DURING ALL TRAINING. PLEASE FOLLOW THE RULES; THESE ARE FOR YOUR OWN SAFETY. \*PPE/SCBA MUST BE NFPA-APPROVED



**NFA 16 HOUR INCIDENT SAFETY OFFICER COURSE**: COURSE IS FOR FIRST RESPONDERS WHO MAY BE DESIGNATED BY THE INCIDENT COMMANDER(IC) AS AN ISO WHILE WORKING WITHIN AN INCIDENT COMMAND SYSTEM(ICS) THE ASSIGNMENTS MAY OCCURE DURING FIREFIGHTING, EMS, SPECIAL OPERATIONS TYPE INCIDENTS AND TRAINING EVOLUTIONS. IT IS AN INCIDENT-SPECIFIC, SCENARIO-ORIENTED COURSE DESIGNED TO TEACH STUDENTS WHAT AN ISO NEEDS TO KNOW AT AN INCIDENT.
